

Program Data Point 11. Student Clinical Site Evaluations

Using feedback from students, the program developed a concise set of questions aimed at evaluating site supervision and students' overall site experiences. In the summer of 2023, the program revised the forms students use to evaluate their placement sites and site supervisors, increasing the number of data points for both instruments. The following tables detail the data collected.
